For the lump-sum death benefit and supplementary lump-sum death benefit, the insured person may change the order of beneficiaries within the same category of beneficiaries (A, B, C) and/or determine that the split of the death benefit between several beneficiaries in the same category can be made in unequal parts (art. 46 and 47 of the Pension Regulations). The order of the beneficiary categories cannot be modified.

**This clause must be accompanied by a copy of the insured person's identity document and sent to the CIEPP by post or electronic mail, or deposited at the counter.**

**It must be communicated to the Fund during the insured person's lifetime.**

The insured person is responsible for regularly updating the clause communicated to the CIEPP, particularly in the following cases:

- in case of a change of mind;
- in the event of the death of one or more designated beneficiaries;
- in the event of submission to the CIEPP of a declaration of life community;
- when a designated beneficiary no longer meets the conditions of the category in which he/she is included (e.g. orphan).

If you designate several beneficiaries and one or more of them dies before you or no longer meet(s) the conditions required at the time of your death, the lump-sum death benefit as well as the possible supplementary lump-sum death benefit are split between the other designated beneficiaries.

In the event that payment to the designated beneficiaries is not possible, the benefits will be paid in line with the regulatory provisions.

This designation is only valid provided that the Regulations, or where applicable the legislation in force, are not modified.
